

Process Flowchart

For Players wishing to transfer to another club after registration

Download Player Transfer and Player Dispensation forms from the www.nzihha.com website or request them from your club and/or nz.inline@gmail.com

If NO REGIONAL CHAMPIONSHIP GAMES have been played for your local club.

Complete Transfer Form ONLY

Apply (player or (if under 18 yrs) parent/guardian) signature

Send copy to NZIHA to allow database update and notify your current club of your wish to transfer.

Player is permitted to play for their new club after acknowledgment from NZIHA is received.

If ONE OR MORE REGIONAL CHAMPIONSHIP GAMES have been played for your current club...

Complete Transfer and Dispensation Forms giving complete details of all Regional Championship games played and reasons for application to transfer

Apply (player or (if under 18 yrs) parent/guardian) signature and obtain signatures from current club and new club committee member

Send both signed forms to NZIHA to consider application for dispensation.

Player is not permitted to play any games until the application outcome is known. Outcome should be available within 3 - 5 days.

All players requesting dispensation and/ or transfer should ensure that they return any equipment and/or uniform and pay any outstanding fees to their current club prior to changing clubs. All unpaid fees and equipment or uniform not returned is a matter to be resolved between the individual and the club.

NZIHA updates database where notification and/or approval is given and both clubs are advised of the outcome. If approval is given the player, can continue to play for the new club in regional championship. If approval is NOT given, the player is given option of transferring without eligibility to continue to play in regional championship or remaining with current club.

Player Transfer Notification

Players may only play in teams representing the club that first registers them in that competition year unless a transfer is obtained under the provisions of NZIHA By-Law 104B. In regional and national championships a player may play for only one club throughout the competition unless dispensation is granted by NZIHA.

This form must be completed **by any player** wishing to transfer to another club after annual registration with their current club using the "process flowchart" as a guide to complete documentation.

A player wishing to transfer to another club and continue to be eligible to play in regional AND/OR national championships MUST submit this form and also the Player Dispensation Application to the NZIHA. The player MUST wait for notification from the NZIHA of the outcome PRIOR to participation for either club.

Signatures from **BOTH clubs** are only required in the case of application to transfer being requested after player has commenced playing for current club in regional championship games.
