Team Officials Agreement

This agreement covers the conditions by which I have been appointed as an official of a _____
New Zealand Team competing at the Oceania 2011 competition being held in Carrara.

I acknowledge that my appointment is conditional upon my entering into this agreement and observing its terms and conditions in their entirety.

This agreement will commence on March 1st, 2011 and conclude on 31st July 2011.

I understand that I am required to travel to and from New Zealand with the team I have been assigned. For the term of this agreement, I agree to:

1. Observe and comply with the terms of this agreement in its entirety.
2. Conduct myself to the highest standard expected of a New Zealand team official.
3. Work with all NZIHA appointed officials (ie the Team General Managers, Coach and Team Officials etc) to:
 - Create a unified and professional team.
 - Ensure that the athletes conduct themselves to the highest standard expected of a New Zealand representative team.
 - Assist as required in aspects of administration, supervision, welfare, transport, meals, uniforms and other tasks delegated by the NZ General Managers, Manager and/or Coach.
 - Positively support, guide and encourage the athletes at all times both on and off the rink.
 - Minimise, as far as possible, distractions that may prevent the athletes performing to the best of their ability.
 - Actively try to ensure no player uses, attempt to use, have in their possession or attempt to have in their possession, traffic or attempt to traffic in any illegal drugs or banned substances in New Zealand and/or in the country the player is visiting.
4. I will:
 - Attend, all team training sessions and meetings organised by the Team Coach at the Event.
 - Comply with the NZIHA constitution, bylaws and policies, the rules governing the competition and national and international regulations.
 - Manage, supervise and monitor players to ensure
 - I know of their whereabouts at all times while on tour
 - their actions and behaviours will not cause harm to themselves, others or to the property of others
 - Ensure that my registration as a member of NZIHA is current.
 - Be conversant with the NZ Drugfree Sport, SPARC & WADA Anti-Drug Policy and testing procedures and ensure full compliance with its requirements. In particular, monitor medication taken by athletes to ensure they fully comply with these requirements. However it is acknowledged that all players are responsible for their own medications and also responsible for ensuring appropriate permissions required by WADA Anti-Doping Policies.
 - Comply with the laws of New Zealand in every respect and those of the country hosting the event.
 - Not use, attempt to use, have in my possession or attempt to have in my possession, traffic or attempt to traffic in any illegal drugs or banned substances.
 - Refrain from making any public criticism or statement having or designed to have a prejudicial effect on the interests of the NZIHA, the team or its officials.
 - Acknowledge and co-operate with any sponsors associated with the NZIHA.
 - Conduct myself in a proper manner so as not to bring myself, the team or the NZIHA into public disrepute.
