IHNZ Junior Interconference Event Notice 2024

The organiser for the Junior Interconference Event for the 2024 season is IHNZ. A Tournament Director and Referee in Chief will be appointed for the duration of the tournament.

Venue and Dates:

Dates: Saturday 14 September to Sunday 15 September 2024 Venue: 30 Old Farm Road Hamilton East Hamilton 3216

Eligibility:

To participate in this tournament, all players must be registered with IHNZ and an IHNZ Affiliated Club or obtained consent from IHNZ to play without IHNZ or club registration. The clubs they represent must be incorporated under the Incorporated Societies Act.

The grades offered at this tournament are as follows:

- 10U
- 12U
- 14U
- Junior Women (all eligible female players including the 3 age grades listed).

Any dispensation requests must be received in writing by the Organising Committee no later than 5.00 pm on 16 August 2024.

Official Rule Book and this Event Notice:

This event will be played under the current IHNZ Rule Book.

Where the IHNZ Rule Book and the Event Notice conflict the Event Notice will take priority.

Tournament Rules:

- Closing date for registration is 25 August 2024
- All tournament decisions will be at the sole discretion of the Tournament Director
- Team ages must be adhered to as per the rules of IHNZ being adopted for the 2024 season
- IHNZ reserve the right to withdraw a grade due to insufficient entries

Draw:

- The draw will be published as soon as practicable on the IHNZ Facebook page and on the IHNZ website;
- The Organising Committee and/or the Tournament Director reserves the right to alter the schedule of games or make whatever operational changes are deemed necessary in the case of unforeseen circumstances.
- Any changes will be posted on the IHNZ Facebook page

Disputes and Discipline:

- All match penalties, disputes or protests will be handled by the Organising Committee who will appoint a Tournament Discipline Committee ("TDC")
- The composition of the TDC and it's processes will follow the guidelines set out in the IHNZ Disciplinary Procedures.
- All protests must be accompanied by a fee of \$30 (refundable if protest is upheld)
- The TDC is empowered to discipline players, teams, team officials, and clubs for their conduct both on and off the rink before, during and after a game.
- This Disciplinary Committee may impose disqualification, suspension, fine and/or other measures as deemed appropriate by the Committee.
- Hearings will be conducted at a time notified to the parties involved by the Tournament Director, and as far as is practical, during the Tournament.
- Penalties imposed in this Tournament will, if applicable, carry over to further IHNZ sanctioned games.
- Details of all Disciplinary Panel matters are to be forwarded to IHNZ.

Entry Fee:

The entry fee is \$350 per team (GST incl) payable by 31 August 2024. (Spectator entry is free of charge).
